# **Tenancy Matters**

### **Subletting Your Property**

Subletting is when you don't intend to live in your home for a set period of time and it's then let in part, or in its entirety by you, to a person who is not the principal tenant. Before you apply to sublet, you must have been the tenant of the property throughout the 12 months immediately prior. You must always contact us in advance to clarify queries and/or to discuss plans to sublet. You need our written consent before

Here are the main points you should know:

proceeding with a proposed sublet.

- You should apply to sublet in writing and we will send an application.
- We will acknowledge all applications within 3 working days, and will give our decision within 28 days.
- If approved, you will be able to sublet your property for a maximum of 9 months.
- We are able to refuse permission if we have reasonable grounds.
- Proceeding with a sublet without our permission is considered a serious breach of the tenancy and is likely to result in legal action for recovery of the property.

### Don't Abandon Us!

If you're thinking of ending your tenancy and don't know how to go about it please get in touch and we'll be happy to guide you through the process and the required 28 days written notice.

If we suspect that you have abandoned your home we'll make necessary checks before issuing a statutory notice to end your tenancy. This may include contacting your next of kin, neighbours and GP amongst others.

# Home Safety and Investment Update

We have recently completed our Lift and CCTV Modernisation Projects, with the preparation for our 2021/22 Investment programme underway :

- Windows replacements to 230 properties
- Electrical Safety, Smoke & Heat Detectors to 1100 properties
- Link Corridor glazing replacement benefitting 182 properties
- We have commissioned investigation works for Stonework at Byres Road as the pilot project of a 5 year programme across relevant tenement stock.
- Cyclical Painting inspections are complete with plans due to begin in Nov/ Dec 2021.
- Heating and Hot Water (Blythswood Court and St Vincent Terrace) and Kitchen and Bathroom replacement works are in development.

#### Asbestos Awareness

Asbestos has been used in the construction and modernisation of housing for many years in Glasgow. Although it may sound alarming to know that asbestos is present within your home, it is largely safe if left untouched.

- Any essential works in areas where asbestos is known to be present, will be completed in accordance with health and safety regulations. This includes the removal of asbestos.
- We have established processes in place to ensure tenants are aware if there is asbestos in their property.
- If you plan on carrying out alteration works within your home, and need a reminder of where asbestos is located, let us know in advance and we will provide information on the presence of asbestos in your home.

#### Fire and Smoke Alarm Regulations - Keep Your Home Safe from Fire

Our Electrical and Fire Safety works involve upgrades and testing to ensure appropriate safety measures are in place, and that homes meet new fire and smoke alarm regulations. The target completion date for these was extended to February 2022 due to the impact of the Covid-19 pandemic.

The new regulations mean homes need:

- smoke alarm in every circulation space on each storey, such as hallways and landings.
- All heat and smoke alarms interlinked.
- A carbon monoxide detector where there is a fuel burning appliance or a flue.
- A smoke alarm in the living room.
- A Heat alarm in the kitchen.

Once a contractor has been appointed, and the works programme is established, we will tell you the timescales, relevant information, and agree access arrangements.

Here are some top tips from the Scottish Fire and Rescue Service to keep your home safe from fire.

- Test your fire alarm a minimum of once per month to ensure it is in working order.
- Close your internal doors at night to help slow down the potential spread of flames.
- Never leave a cooker unattended while in use.
- Keep lit candles away from children and pets, curtains, throws and other flammable materials.
- Keep stairwells clear for a safe exit in case of fire
- If you have gas heating, we will carry out an annual visit. Please allow access for this essential check.



### Gas Safety Week 2021

**Gas Safety Week** sees organisations from across the UK working together to raise awareness of the dangers of poorly maintained gas appliances, which can cause gas leaks, fires and carbon monoxide poisoning. We ask everybody to adopt this approach all year round, and proactively allow and arrange access for annual inspections with our contractor.
