Principle Exclusions applicable to Building Section:	<ul style="list-style-type: none"><li>• Loss or Damage caused by anything that happens gradually.</li><li>• Loss or Damage caused by corrosion, rust, wet or dry rot, shrinking, evaporation, dampness and wear and tear.</li><li>• The cost of correcting faulty workmanship or design or the cost of replacing faulty materials.</li><li>• Loss or damage caused by chemicals reacting with any materials which the buildings are built from.</li><li>• Loss or damage caused by pets, insects or vermin.</li><li>• The cost of maintenance, normal redecoration and preparation for occupancy.</li><li>• The cost of replacing, repairing or changing any undamaged items or parts of items forming part of a set, suite, carpet or other items of a common nature, colour, design or use.</li><li>• Loss or Damage which happens before the start or which arises from an event before cover starts.</li><li>• Loss or Damage caused deliberately by you.</li><li>• Commercial Loss of Rent unless agreed otherwise in writing.</li><li>• Commercial short term residential lets such as AirBnB are an excluded activity.</li></ul>
